

# New Minimum Wage for Employees in Ontario

Effective October 1, 2020, the general minimum wage for employees in Ontario increased by 25 cents, to \$14.25 per hour. This is the first time the minimum wage has increased since January 2018. Under the *Making Ontario Open for Business Act*, this increase is tied to the Ontario Consumer Price Index (CPI) for 2020 (i.e. the inflation rate).

The minimum wage rate is the lowest amount, per hour, that an employer must pay an employee, pursuant to the Ontario *Employment Standards Act, 2000*.

Below are summaries of the minimum wage rates in Ontario for various types of employees and the general minimum wage rate for each of the provinces and territories.

Minimum Wage Rates Across Canada

Province	Minimum Hourly Wage	Notes
Alberta	\$15.00	Effective as of October 1, 2018
British Columbia	\$14.60	The minimum wage will increase to \$15.20 on June 1, 2021.
Manitoba	\$11.90	Effective as of October 1, 2020. The minimum wage is adjusted annually on October 1 <sup>st</sup> based on the CPI.
New Brunswick	\$11.70	The minimum wage is adjusted annually on April 1 <sup>st</sup> based on the CPI.
Newfoundland and Labrador	\$12.15	Effective as of October 1, 2020.
Northwest Territories	\$13.46	Effective as of April 1, 2018. The regulation in NWT does not specify that there must be an annual increase.
Nova Scotia	\$12.55	Effective as of April 1, 2020. The minimum wage will increase to \$13.10 on April 1, 2021. The calculation for the base wage will return to the CPI formula on April 1, 2022.
Nunavut	\$16.00	Effective as of April 1, 2020. The minimum wage is reviewed annually on April 1 <sup>st</sup> .
Ontario	\$14.25	Effective as of October 1, 2020
Quebec	\$13.10	Effective as of May 1, 2020
Saskatchewan	\$11.32	Effective as of October 1, 2019. The minimum wage will increase to \$11.45 on October 1, 2020. The minimum wage is adjusted on October 1 <sup>st</sup> of each year relative to the CPI.
Yukon	\$13.71	Effective as of April 1, 2020. The minimum wage is adjusted April 1 <sup>st</sup> of each year relative to the CPI.
