She has considerable depth in urgent injunctive relief, particularly freezing and preserving funds and digital assets, as well as with cross-border litigation and jurisdictional disputes. She also advises clients on internal policies and controls, evidence preservation, and regulatory and litigation risks arising from data breaches, cybersecurity incidents, and misappropriations of funds and digital assets. Jessica's clients include private and public corporations, traditional and decentralized financial institutions, not-for-profit organizations, and individuals. Her focus is on achieving practical outcomes for clients and providing strategic clarity in challenging situations and complex litigation.
