Notable Mandates

Contract

- Defended a company selling computers and other electronics located in California in an action commenced in Ontario claiming approximately \$1.8 million in damages for breach of contract, loss of goodwill, loss of reputation and defamation.
- Represented the owner of environmentally sustainable home in an action against a contractor for the negligent performance of the contract, defamation and damages associated therewith.
- Represented the defendant and plaintiff by counterclaim in an action where the plaintiff claimed damages arising from the termination of a construction contract, and the defendant counterclaimed for damages arising from the negligent performance of the work and the cost to remedy the deficiencies in the work.
- Represented a plaintiff from the CGI and graphic design industry in an action against a staffing agency and independent contractor for, among other things, conspiracy, and inducing breach of contract.
