## Significant Cases

C.U.P.E. v. Ontario (Minister of Labour) – Jeff was co-counsel, along with WeirFoulds partner Greg Richards, for the Canadian Bar Association in its successful intervention before the Supreme Court of Canada in this leading case in administrative law involving judicial review of the Minister's discretionary decision to appoint retired judges as chairs of interest arbitration panels in the health care sector.
